- Be open to serving on the Executive Committee and/or being appointed an Officer of the Corporation (Chair, Vice-Chair, Treasurer, Secretary)
- Learn about ITS Canada its mission, strategic plan, tactics, policies, and operations
- Understand your role as a Director and the roles of the staff and other volunteers
- Take action to support the decisions of the Board

Recruiting

- Serve as a mentor for new Board Members and identify new candidates for Board participation
- Encourage colleagues, clients and co-workers to become involved in ITS Canada

Supporting

- Support major events through exhibition, sponsorship, and attendance as well as encouraging others to participate
- Provide leadership to and participate in Committees (see Committee link on website)

- Assess Board performance
- Assess your performance as a Board Director
- Assess the organization's performance
- Review the strategic plan and objectives for the year
- Be prepared to propose changes you feel are needed and/or appropriate
